**Set-Up:** Vendor set-up is Saturday from 630a.m. – 8 a.m. At 8 a.m., Please move all vehicles from the event area.

**Sales Tax:** It is the responsibility of the vendor to collect Maine sales tax.

**Restrictions:** Please move vehicles to designated area except when loading/unloading ONLY. Please sell only what is covered by the agreement. Supplies must be stored out of sight. Smoking, alcoholic beverages and drugs are prohibited. Please leave pets at home, hot cars are dangerous. Pets are not permitted (with the exception of certified service animals).
